MEMORANDUM OF UNDERSTANDING SIGNED BETWEEN OVERSEAS MANPOWER CORPORATION LIMITED AND M/s. KUWAIT GATE FOUNDATION FOR THE RECRUITMENT OF HOUSEMAID TO KUWAIT.

Dr.C.N.Mahesvaran,I.A.S., Managing Director, Overseas Manpower Corporation Limited, Chennai.(A Government Of Tamil Nadu Undertaking) has informed that the Overseas Manpower Corporation Limited has signed the Memorandum of Understanding with M/s. Kuwait Gate Foundation, Kuwait for the recruitment of Housemaid to Kuwait, in Chennai on 17.11.2021.

The Managing Director, Dr. C.N. Mahesvaran, I.A.S., has informed that as per the advice of Hon'ble Chief Minister of Tamil Nadu and as per the guidance of Hon'ble Minister for Labour Welfare and Skill Development Department, Overseas Manpower Corporation Limited is taking all the efforts to facilitate employment opportunities to the people of Tamil Nadu to work in foreign countries. He has also informed that the representatives of the foreign countries are being requested to consider the OMCL for recruiting the needed employees to their respective countries. Accordingly, as a First case, Kuwait Gate Foundation from Kuwait approached this office requesting to send 500 Housemaid to work in Kuwait. Accordingly, the Memorandum of



Understanding was signed on 17.11.2021 with Mr. HASAN ABDULRAHMAN, the representative of M/s.Kuwait Gate Foundation.

The main aspects of Memorandum of the Understanding are as follows :-

- ❖ The monthly salary for the fresh employees - Rs.29,500/- and for the gulf experienced employees Rs.32,000/- per month.
- ❖ Age must be between 30 and 40 years.
- ❖ The foreign employer will also bear the entire expenses including Visa charges, Air ticket, Medical Examination Fee for the selected Housemaid.
- ❖ The Housemaids will be provided with assured monthly salary in time, reasonable working conditions, food, accommodation, medical & insurance coverage and other basic amenities as per Kuwait Labor Law.
- ❖ This MoU shall be valid for a period of Two (2) years from the date of signing and may be renewed for similar period(s) unless terminated earlier by either Party by giving the other Party Thirty (30) days prior written notice of termination.
- ❖ The Employer shall supervise and verify that each household/domestic worker has made all the medical



investigations determined by authorities in the State of Kuwait.

- ❖ The employer shall prepare a booklet/ Instruction letter written in the worker's mother language for raising the awareness for each worker
- ❖ This booklet/ Instruction letter shall include the details of the customs and traditions of the State of Kuwait in addition to its public morals and the rights and obligations of the worker.
- ❖ The Employer will ensure that the local employer pays the agreed monthly salary to the Workers in time.
- ❖ Proper and reasonable working conditions of Workers with healthy accommodation condition are to be provided for the employee.
- ❖ The Workers will be allowed for reasonable communication with their spouses or family in back home.
- ❖ It is also to be ensured that no physical or mental harassment to be allowed by the sponsor or other inmates in the house.

The Managing Director has also informed that the interested persons can get the complete details/terms and conditions of the



MoU either in the office of OMCL Chennai, or the District Employment and career Guidance centre in the respective districts.

Hence, the candidates interested to work Housemaid may apply with resume, copies of qualification, passport and photo to the Email omchousemaidkuwait21@gmail.com. Interested persons may visit OMCL website www.omcmanpower.com (or) contact over phone 044 22505886/22500417.

Since the Agreement is valid upto 17.11.2023, the willing people can register until then. However, the list of the people will be sent to the employers on seniority basis.
